## Dear Kent Employer:

We need your help learning more about the housing circumstances and needs of your employees, and how the housing situation in the area has impacted your business or organization.

The Connecticut Housing Finance Authority has funding available to develop housing that would be restricted to people who work in Kent. This is different from most affordable housing funding sources, which require that housing be made available to all who meet the income restrictions. Development of this workforce housing in Kent has the potential to have very real and tangible benefits for employers like you.

We've heard plenty of anecdotes about how the housing situation has impacted employers, but before we can pursue this funding, we need actual data. We've created two surveys to get the data we need.

We should also note that many of your employees may be eligible to apply for our existing housing at South Common and Stuart Farm. Current eligible income ranges are \$20,075-\$64,240 per year for a single person, or \$28,675-\$91,760 per year for a family of four. Additional information is available at
